Return to In-Person Instruction & Continuity of Services Plan

- 1. Assumption of Risk**—The Novel Coronavirus, Covid-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly through person-to-person contact.
 - A. The Ellendale School District has put in place preventative measures to reduce or slow the spread of the COVID-19 virus; however, the District cannot guarantee that individuals will not become infected with COVID-19. And school attendance could increase the risk of contracting COVID-19.
 - B. The mitigation planning and strategies laid out in the plan are intended to be responsible, reasonable, realistic strategies that the school can implement on a daily basis.

- 2. Mitigation Efforts**—To limit close contact scenarios and slow the spread of COVID-19 at school:
 - A. Campus facilities are cleaned on a regular basis to provide our staff and students with a clean, safe, and healthy environment.
 - B. Promote healthy hand hygiene along with proper cough/sneeze etiquette. Allow for optional mask wearing, promote social distancing where practical, encourage home screening before school and expect people with symptoms/illness to stay home and consult medical professionals, if appropriate.
 - C. The District supports, but does not require, members of the school community to get vaccinated. Face coverings are supported, but not required.
 - D. Appropriate social, emotional, and mental health needs will be available for the school community upon request.
 - E. Classroom and Special Education modifications and accommodations will be provided to the fullest extent possible, with the health and safety of students and staff a priority.

- 3. Positive Cases**—In the Building:
 - A. Report any COVID-19 related symptoms immediately. If symptomatic, students/staff will be required to leave the school, quarantine and consult with their medical provider about being tested for COVID-19. The District does have a limited supply of test kits for student use.
 - B. When students are required to be out of school for self-isolation they will:
 - Not be eligible to participate in activities unless there is a virtual option.
 - Make contact and arrangements with each teacher to meet virtually and/or make up missed work.
 - Any student required to be out of school can participate in school lunches that will be take-home sack lunches. Parents must contact the school by 8:45 AM on the first day of the week, for the time their student will be out of the building.
 - Parents are encouraged to monitor their student’s social, emotional, and mental health. The school will provide counseling services with school personnel upon request.

- 4. COVID Testing**—Exclusion from school:
 - A. Whenever a student has been identified as having signs and symptoms of COVID-19, an at-home test is recommended, or they can be tested by their health care professional. The District does have a limited supply of test kits. Students will be required to stay home until their test results come back.
 - **Positive Result:** Stay home 5 days from the day of testing (day 0); return fever-free without fever-reducing medication for 24 hours.

- **Negative Result:** Stay home until fever free without fever-reducing medication for 24 hours.

5. School Instructional Phases:

- Phase 1**—Open for live attendance following mitigation processes listed above. The District will work to keep school open for as much on-site instruction as possible.
- Phase 2**—Remote learning when the school building is closed to on-site attendance.
- The School District may move to remote learning for one of the following reasons: (The number of closure days required for remote learning will depend on the circumstances.)
 - Due to state or federal mandate.
 - If there is no longer enough staff in the building to provide direct instruction due to their own exposure to COVID-19. When adequate staffing is available, the district would return to on-site instruction for all healthy students.
 - Administrative discretion deemed necessary in extreme circumstances.
- All Ellendale Public School employees are considered essential employees.
- The District ICU program for JH/HS students, and the after-school program for elementary students provides extra support to ensure minimal learning loss.
